Review of Lancaster's Local Plan

What changes would you like to see from a climate change perspective?

What does a Local Plan do?

The Local Plan is written by the Council and sets the policies against which planning applications in Lancaster district are determined. It covers areas such as housing, employment, the environment and recreation, infrastructure, transport and heritage and conservation. The Local Plan is written following in-depth consultation and is based upon a significant and robust evidence base. It sits within a national policy framework but ensures that local issues are considered and addressed within its policies.

Hasn't the Council just written a Local Plan?

Yes! The Council adopted the current Local Plan in July 2020 but wants to do further work to ensure climate change is given even more focus.





So why is the Council reviewing the Local Plan so soon?

Like many Local Authorities, Lancaster City Council declared a climate emergency in January 2019. Whilst the adopted Local Plan does seek to address climate change, the Climate Declaration came too late in the preparation of the Plan to fully influence the actions and directions of the declaration. A revised plan to take account of climate change is therefore being produced. The benefit of a recently adopted Plan means that the detail included in the Plan is up to date and therefore the Council can focus purely on Climate Change issues and addressing this important agenda in the best way for Lancaster District without having to re-visit other matters.

The Plan will not therefore revisit housing and employment land allocations and numbers and other areas such as Bailrigg Garden Village. The review will also only consider climate change issues in the context of the planning system. Other climate change activities are being dealt with by the Council separately to this review.

What is the Climate Emergency declaration?

On 30 January 2019 Lancaster City Council declared a Climate Emergency. This committed the Council to a number of actions including convening a Citizens' Assembly to help identify how the Council's own activities might be made net-zero carbon by 2030.

Progress is being made and in November 2019 the Council's Cabinet endorsed an outline plan to reduce the Council's own direct CO2 emissions to net-zero by 2030. The January 2019 declaration also committed the Council to work with partners across the district, county and region to help deliver this new goal through all relevant strategies, plans and shared resources. While the Council has not set a target for all activities
