The Government continues to manage the risk of serious illness from the spread of the virus. Step 4 marked a new phase in the government's response to the pandemic, moving away from stringent restrictions on everyone's day-to-day lives, towards advising people on how to protect themselves and others, alongside targeted interventions to reduce risk. As COVID-19 becomes a virus that we learn to live with, there is now an imperative to reduce the disruption to children and young people's education - particularly given that the direct clinical risks to children are extremely low, and every adult has been offered a first vaccine and the opportunity for 2 doses by mid-September.

As advised by the Government, school's priority now is to deliver face-to-face, high-quality education to all pupils. As the evidence is clear that being out of education causes significant harm to educational attainment, life chances, mental and physical health.

In order to do this, Willow Lane Primary School regularly refer to official advice from DfE, PHE, HS&Q, HR and the school Advisory Team.

At Willow Lane, we regularly review and update our risk assessments - treating them as 'living documents', as the circumstances in our school and the public health advice changes. This includes having active arrangements in place to monitor whether the controls are effective and working as planned to protect staff, pupils, visitors and families. Any updated risk assessments will be shared with parents, carers, staff and pupils (in a child friendly format).

Staff or pupils displaying symptoms of COVID19	 Pupils, staff and other adults should follow public health advice on <u>when to self-isolate</u> and what to do. They should not come into school if they have symptoms, have had a positive test result or other reasons requiring them to stay at home due to the risk of them passing on COVID-19 (for example, they are required to quarantine). If anyone in your school develops <u>COVID-19</u> symptoms, however mild, you should send them home and they should follow public health advice. If a pupil in a boarding school shows symptoms, they should usually self-isolate in their residential setting so that their usual support can continue, others may then benefit from self-isolating in their family home. For everyone with symptoms, they should avoid using public transport and, wherever possible, be collected by a member of their family or household. If a pupil is awaiting collection, they should be left in a room on their own if possible and safe to do so. A window should be opened for fresh air ventilation if possible. Staff or pupil tests positive for COVID19 using a Lateral Flow Test.	Confirmatory PCR tests Staff and pupils with a positive LFD test result should self-isolate in line with the <u>stay at home</u> <u>guidance for households with possible or</u> <u>confirmed coronavirus (COVID-19) infection</u> . They will also need to <u>get a free PCR test to</u> <u>check if they have COVID-19</u> . Whilst awaiting the PCR result, the individual should continue to self-isolate. Staff or pupil tests positive for COVID19 using a PCR Test, Contact tracing and self- isolation.	Under-18s, irrespective of their vaccination status, and double vaccinated adults will not need to self-isolate if they are a close contact of a positive case. They will be strongly advised to take a PCR test and, if positive, will need to isolate.	 Staff member or pupil will be directed to self-isolate for 10 days from the onset of symptoms or the day of the test is asymptomatic. Staff member or parent of pupil will be asked to inform NHS Test and Trace to help identify potential close contacts. Close contacts will be identified via NHS Test and Trace and education settings will no longer be expected to undertake contact tracing. As with positive cases in any other setting, NHS Test and Trace will work with the positive case to identify close contacts. Contacts from a school setting will only be traced by NHS Test and Trace where the positive case specifically identifies the individual as being a close contact. Close contact individuals are not required to self-isolate if they are fully vaccinated, below the age of 18 years and 6 months, have taken part in an approved COVID19 vaccine trail or are unable to get vaccinated for medical reasons. Instead, they will be contacted by NHS Test and Trace and advised to take a PCR test. Therefore, school staff (if fully vaccinated) and pupils can attend school as normal unless they show symptoms of COVID19. For pupils who are instructed to self-isolate because they display COVID19 symptoms and/or have tested positive for COVID19 through a PCR test, remote learning opportunities will be put in place if they are well enough to access them.

Mechanical ventilation is a system that uses a fan to draw fresh air, or extract air from a room. These should be adjusted to increase the ventilation rate wherever possible and checked to confirm that normal operation meets current guidance and that only fresh outside air is circulated. If possible, systems should be adjusted to full fresh air or, if this is not possible, then systems should be operated as normal as long as they are within a single room and supplemented by an outdoor air supply. Where mechanical ventilation systems exist, you should ensure that they are maintained in accordance with the manufacturers' recommendations. Opening external windows can improve natural ventilation, and in addition, opening internal doors can also assist with creating a throughput of air. If necessary, external opening doors may also be used (if they are not fire doors and where safe to do so). Staffing	School leaders are best placed to determine the workforce required to meet the needs of their pupils. Clinically extremely vulnerable (CEV) people are advised, as a minimum, to follow the same guidance as everyone else. It is important that everyone adheres to this guidance, but CEV people may wish to think particularly carefully about the additional precautions they can continue to take. Further information can be found in the guidance on protecting people who are CEV from COVID-19.	 Willow Lane recognises that mental health of staff may still have been adversely affected during the COVID-19 crisis. The Headteacher or other senior personnel will keep in regular contact with staff to monitor their working arrangements and offer support and advice where necessary. Staff are able to make contact with a colleague or manager for advice and support, or just for reassurance, during the normal working day. This can be directly or through the wellbeing groups. School provides a 'Staff wellbeing and Support Plan' provided by New Start. This allows staff to talk to a counsellor every half term as needed. These sessions are held following strict guidelines with regard to safety and social distancing.

	Social distancing measures have now ended in the workplace and it is no longer necessary for the government to instruct people to work from home. Employers should be able to explain the measures they have in place to keep CEV staff safe at work. FOLLOWING CONTAMINATION	 Shared cleaning protocols document allows for monitoring. PPE is provided for staff to wear during cleaning activities and must be worn as instructed e.g. gloves, aprons etc. COSHH risk assessments are in place and followed for cleaning products and have been shared with staff as necessary.
Disposal of Waste	 All staff have been given the following instruction in respect of waste generated from the home testing process: Packaging can be disposed of with general household waste; Once empty the extraction buffer sachet should be placed in the plastic waste bag provided; Once the extraction tube has been used it should be placed in the plastic waste bag along with the swab; Once the test has been completed all the used contents of the kit should be placed in the waste bag provided and disposed of with general household waste.

This risk assessment applies to this school providing the control measures described are in operation and there are no further local significant hazards. If it does not fully apply and further control measures are required, the Action Plan at Part C will be completed. This risk assessment will be used as a 'live' document and updated on a regular basis.
